

**GENERAL TERMS AND CONDITIONS OF SALE FOR PARTICIPANTS IN THE UGI CONGRESS EXCURSIONS PARIS
2022**

UPDATED TO 18 JANUARY 2022

(These Terms and Conditions are written in French and English. In case of discrepancies between the texts, the French text will prevail).

I - REGISTRATIONS

1. SCOPE OF APPLICATION

1.1. These general terms and conditions of sale apply, to the exclusion of all other provisions, to any registration for a paying excursion by a participant (the "Participant") to a congress ("the Excursion") organised by the CNFG within the framework of the IGU Paris 2022 CNFG congress.

1.2. The general terms and conditions of sale are available on the website / <https://www.ugiparis2022.org/fr/programme-social/excursions/31Excursion>

1.3. By registering for an Excursion on the website, you accept these terms and conditions in full and without reservation.

1.4. The CNFG reserves the right to modify the terms of these conditions. Only the general terms and conditions of sale in force on the day of registration will apply to the registration concerned.

2. REGISTRATION - CONTRACT

2.1. Registration for the Excursion is made by completing the form directly online on the Site or on the Excursion form.

2.2. Payment of the registration: the full payment of the registration fee must be made to the CNFG at the time of registration, in cash, without discount. The Participant must make his or her registration and payment jointly online. If payment is not received by the deadline, the Participant's registration will not be taken into account.

2.3. Once the registration has been received by the CNFG and payment has been made, the CNFG will send the Participant a summary by e-mail validating his/her order and registration for the chosen Excursion (the "Order Confirmation"). If the CNFG is unable to meet the Participant's registration request (in particular due to a late request or a problem of availability), the CNFG will inform the Participant and will refund the price of the registration within 7 days by transfer to his bank account.

2.4. The contract is considered definitively concluded when the CNFG sends the Order Confirmation, subject to the proper receipt of payment.

2.5. The participant has a right of withdrawal that can be exercised within 14 calendar days from the date of the Order Confirmation, without having to give a reason. It will no longer be possible to exercise the right of withdrawal 14 calendar days before the start of the Tour. The Participant who wishes to exercise this right of withdrawal must notify it, within the legal time limits indicated above, by sending the standard form attached at the end of these general terms and conditions of sale by e-mail to the address: excursionparis22@cnfg.fr. The price of the registration will then be reimbursed, if it had been cashed, within a maximum period of 14 days.

2.6 Registration for excursions is reserved exclusively for registrants of the IGU Congress.

3. TARIFFS - REGULATIONS

3.1. The fees are per Participant, all taxes included. They may be modified by the CNFG. The applicable rates are the rates in force at the time of registration (rates appearing on the website or the form at the time of registration).

They include all the services described in the online description of the excursion, for the corresponding price.

3.2. Subject to what is stated in article 3.3, registrations will only be made through the *HelloAsso* platform, the links to which are shown on the Website (one link per excursion).

3.3. Once paid, the prize may only be refunded in the cases set out in articles 2.5 and 5 of this Agreement.

4. OBLIGATIONS OF THE PARTICIPANT

Registration with the CNFG implies acceptance of the following conditions:

4.1. Each registration is valid only for the Excursion mentioned and cannot be accepted for another Excursion.

4.2. The Participant will receive a receipt by email. The receipt is personal, non-transferable and must be presented at the start of the Excursion. The organiser reserves the right to carry out an identity check during the Excursion to ensure that it corresponds to the identity of the bearer of the receipt.

4.3. The Participant undertakes to respect the regulations of the sites visited, as well as the regulations in force in France for access to public places in the context of health constraints. The CNFG reserves the right to refuse participation in the Excursion to any person who does not respect this commitment, without obligation to reimburse.

4.4. The Participant undertakes to respect the conditions of accessibility specified on the website and to report any specific needs that may prevent or restrict the provision of the services provided.

4.5. The Participant is solely responsible for any loss or damage he/she may suffer during the Excursion.

5. MODIFICATIONS - CANCELLATIONS

5.1. In the event that, having expired, the Participant wishes to cancel his/her participation, he/she must notify the CNFG by e-mail at least 10 working days before the Excursion.

In this case, the CNFG will not reimburse the participant according to the cancellation conditions below and appearing on the Site or the registration form.

No request for refund for cancellation of registration for the Congress or the Excursion will be accepted. The registration fees for the Excursion remain definitively with the CNFG. In compliance with the above point, if the participant is absent from the Conference, either face-to-face or online, no refund will be made for cancellation of participation in the Congress.

5.2. In case of necessity, the CNFG reserves the right to modify the program of the Excursion.

5.3. The CNFG cannot be held responsible and no reimbursement will be due if the Excursion is delayed or cancelled due to force majeure or an act of God, such as an attack or act of terrorism, civil war, riots, epidemic, state of emergency, natural disaster.

6. INTELLECTUAL PROPERTY - IMAGE RIGHTS

6.1. The interventions of the speakers, the documents distributed or handed out during the Excursion are covered by copyright in application of articles L 111-1 and following of the Intellectual Property Code. Under the terms of article L 122-4 of the Intellectual Property Code, "*any representation or reproduction, in whole or in part, made without the consent of the author or his successors or assigns is unlawful*". Article L 122-5 of this code only authorises "*copies or reproductions strictly reserved for the private use of the copier and not intended for collective use*" and "*analyses and short quotations*", "*provided that the name of the author and the source are clearly indicated*". Any unauthorised representation or reproduction, by any means whatsoever, which does not comply with the legislation in force shall constitute an infringement punishable under Articles L 335-2 and L 335-3 of the Intellectual Property Code. The Participant shall be held liable if unauthorised use is made of the interventions, documents distributed or handed out during the Excursion.

6.2. The Participant is informed that the CNFG may be required to take photographs and/or films during the Excursion. Unless he/she expressly declares otherwise, the Participant authorises the CNFG to photograph or film him/her during the Excursion and to distribute and reproduce these images on any medium, as part of the online distribution of the Excursion or communication about the Excursion.

6.3. Speakers are solely responsible for what they say during the Excursion.

7. PROTECTION OF PERSONAL DATA

7.1 Personal data

The CNFG has a Personal Data Protection policy, the characteristics of which are explained on the explained on the Site or the registration form.

7.2. Management of cookies

During a visit to the Site or the registration form, cookies or cookies are likely to be installed in your terminal User.
